Image Requirements

1. Digital file must be in JPG format. File size should not exceed 3MB. Image resolution allowed up to 300dpi, jpg. For best presentation of your work, resolution of 300dpi is preferred.
2. No digital enhancement is allowed.
3. The image **MUST** be oriented correctly (vertical or horizontal).
4. Crop images to exclude mat and frame.
5. Save the image with your name, entry "A" or "B", 2021, and painting title.  
(example: smith, johnA2021flower.jpg) This information must match your entry form.

CD Submission

**Please note that CD's will NOT be returned.**

1. **Each digital image must be on a separate CD.**
2. Label each CD: Name, WSI Juried Exhibit 2021 painting title, "A" or "B"  
Image size (painted surface only – exclude mat and frame)

Email Submission

1. The body of the email must include your name, painting title, entry "A or "B". This information must match your entry form.
2. **Attach one entry per email.**
3. Email entry to Watercolor Society [wsiemail@ori.net](mailto:wsiemail@ori.net) with "Juried Exhibit Entry 2021" in the subject line.
4. Entry form and payment or online submission must be received before the digital image is processed.

## Rules

1. The Juried Show competition is open to current and former residents of the State of Indiana. You must be a current member of the WSI.
2. Artist may submit either one or two paintings. Please note entry fees. If an artist enters two paintings, only one painting can be selected by the juror for the exhibition.
3. No triptychs or diptychs will be accepted.
4. All entries must be the original concept and execution of the artist. No copies of paintings or published photographs will be accepted.
5. No work produced in class or under tutelage of an instructor will be accepted.
6. No work previously exhibited in any JURIED show in Indiana will be accepted. This includes competitions such as the Indiana State Fair, SALI, IAC, IHA and Hoosier Salon.
7. **Work must have been executed with water based medium.** Pastels and charcoal may be used only to enhance or embellish the watercolor. Collage is acceptable. Collage elements must be painted by the artist. No preprinted or computer generated images.
8. The size limitation is 42" x 36" in any direction including frame. No exceptions per IMA @ Newfields rules.
9. **All work must be framed, matted and under glass.** Plexiglas is preferred for all art work and is required if metal frames are used. A simple gallery-quality frame is **highly recommended.** A white or neutral mat is **strongly recommended.** The mat should be at least 3 inches wide, 4 inches preferred on larger paintings.
10. Strap hangers are required. Saw tooth hangers will not be accepted.
11. Titles and prices will be listed as they appear on the entry forms. No changes will be made after entry forms are received.
12. No further work can be done on a painting once it is accepted. The painting will not be accepted if it is different from the original image submitted.
13. If someone other than your area representative will be picking up your painting on September 26, you **must** email WSI director with the name of designated individual. ID may be required upon painting pickup.

## Unclaimed Paintings

There is a **\$45 handling charge** if office personnel or volunteers (other than your area representative) are required to transport your painting from the IMA after the exhibit is over. Paintings may be claimed at the WSI office when the \$45 fee is paid. Unclaimed paintings become the property of WSI after 6 months from the pick-up date of the exhibit.

## Social Security Number

Entrant agrees to provide his/her Social Security Number to the WSI Office upon request for the purpose of WSI's tax return, if an entrant receives \$600 or more in sales and/or awards per year from WSI.

### Shipping

If a painting is accepted and shipped, it must be crated and delivered to the WSI office by **Friday, June 18**. The WSI office will return an unsold painting in the same crate in which it was received. **The artist must set up an account with FedEx or UPS so that all shipping costs are prepaid.** The artist will also be charged the **\$60** handling and transport fee. ### Awards

WSI will award as many cash awards as the 2021 Awards Fund will support.

### Sales

All sales will be conducted through the WSI office. WSI will keep a 30% commission of the sale.

### Risk
