

# WSI Membership Exhibit at the Art Association of Henry County

October 22 – November 20, 2020

## Entry Form

### Eligibility, Dates and Location

Entry into the Watercolor Society of Indiana (WSI) membership exhibit held at the Art Association of Henry County (AAHC) in New Castle is open to all WSI members. This exhibit is a separate event than our annual membership exhibit. **Each member can submit one or two paintings in the exhibit, subject to available space.** The exhibit will take place beginning October 22nd and closing on November 20th, 2020. Painting drop off and pickup dates are detailed below. This provides you an occasion to have your work on display in a wonderful art viewing gallery space. The AAHC facility not only includes the gallery but also classrooms, studio space and a beautiful Arts Park. We encourage you to take advantage of the opportunity to showcase your artwork in the historic west-central Indiana city of New Castle. The **AAHC gallery is located at 218 S. 15<sup>th</sup> Street, New Castle, Indiana.** Note that the **hours of the gallery are currently Tuesday-Friday from 9:30am-2pm** and admission is free to the public.

### Requirements

1. All WSI members who have paid 2020 membership dues may register one or two water media paintings for exhibition.
2. **All entry forms and payments must be received in the WSI office by October 2, 2020;** non-registered paintings will not be accepted.
3. All paintings must be the original work of the artist. No copies or prints of paintings or published photographs will be accepted. In the event of duplicate paintings, neither painting will be exhibited.
4. At least seventy-five percent (75%) of the entry must be watercolor or acrylic media. The balance of the entry may be pastel, charcoal, ink and/or collage (e.g. photos, computer art, fabric, metal foil, etc.).
5. Work must be either...
  - a. Matted and framed under glass. Plexiglass is preferred in metal frames larger than 18" x 24". The overall look of the show is better with neutral mats.

-OR-

- b. With a gallery wrap, i.e. the canvas or paper (painting surface) is stretched around all sides of the stretcher bars and the water media covers all visible surfaces: front, sides, top and bottom. All edges must be finished, with no visible staples, nails or hardware.
6. All work must be ready to hang with flat hangers and wire. No sawtooth or screw-eye hangers will be accepted.
  7. The painting and frame must have a professional appearance and be free from damage or blemishes.
  8. A label with artist name, painting title & painting price must be attached to the back side, top left corner of the painting. If not for sale, write "NFS".
  9. Title and price may not be changed after the entry form has been submitted. If there is a discrepancy between the form and the label, the information on the entry form will be used.
  10. No paintings may be removed before the end of the show.

### Painting Drop Off and Pick Up

Painting drop off is October 20<sup>th</sup> and 21<sup>st</sup> at the AAHC gallery (218 S. 15<sup>th</sup> Street, New Castle) between the hours of 9:30am and 2pm. Alternatively, you can drop off your painting at the WSI office (4181 East 96th Street, Suite 200, Indianapolis) on Monday-Friday between October 5-16 during the hours of 9am to 4pm and they will be delivered to AAHC by WSI volunteers. Neither the WSI nor its staff/volunteers will be held responsible for any loss or damage to the paintings.

Painting pick up is Tuesday, November 24<sup>th</sup> at the AAHC gallery between the hours of 9:30am and 12 noon. Alternatively, you can pick up your painting at the WSI office on Monday-Friday between December 1-8 during the hours of 9am to 4pm. Neither the WSI nor its staff/volunteers will be held responsible for any loss or damage to the paintings. **Any paintings not picked up will incur a \$45 charge if not picked up at the WSI office by December 8, 2020.**

Members outside Indianapolis may arrange free assistance for delivery or pickup by contacting the WSI area representative closest to them.
